



The ASWSI Point System

How to Calculate Points

KEEP IT SIMPLE!

Every 500 points is equivalent to \$0.50
Every 1000 points is equivalent to \$1.00

It is so easy for valued guests to accumulate points. Imagine if you referred a new guest and brought him or her with you to your pre-book appointment to receive salon and spa services together. Then at the conclusion of the visit you purchased retail products. You would generate

500 Pre-book
5,000 Referral
1,000 Spa Service
500 Retail
7,000 Points generated in (1) visit = \$7

How to Use Points

With the **ASWSI POINT SYSTEM**, you have many options to generate points. You can build them up towards future services. You can build them up towards the purchase of gift card. Just remember.

- 1) You can use your points **for up to 25%** of your total bill.
- 2) Your points cannot be used to pay your total amount due.
- 3) They will remain there for you to use freely **within the expiration period**.
- 4) Yes, as with most programs, they have expiration dates. To keep it simple, all points generated in the previous calendar year will expire on February 1st of every year. What does that mean? If you are a valued guest you are always accumulating points. You can use them freely throughout the year. However, if at the end of the year, the remaining unused points you generated from January 1st to December 31st, we are giving you **one more month** in the New Year to use them. If you choose not to use them, in February, your check-out receipt will only reflect points generated in the new calendar year. For liability purposes, we had to implement this clause. However, we feel confident that as a valued guest, you will enjoy the **ASWSI POINTS SYSTEM**.



ONYX MEMBERSHIP

The **Onyx Membership** is designed for our returning Guests who give us permission to automatically withdrawal \$1,000 out of their bank account. The \$1000 will be put into your account for you to use in the Salon, Spa or on our Retail products. Whenever your account reaches \$0, we will use the account information we have in our secured database without the need to contact you. We will need to you complete the Onyx Membership Form to activate your account.

What are the advantages to you?

- No longer need to worry about checking out. At the end of your service, we will have an invoice ready for showing you how much your services were for the day. It will show your balance available as well as your points accumulated that you can use towards salon services, spa services and/or retail purchases. If you want to use your points towards your total for the visit, please let us know when you check-in.
- Your Points Never Expire.
- Within each automatic renewal, you are entitled to (1) free breakfast (7am – 11am), lunch (11am – 3pm) or dinner (3pm-6pm) (*The restaurant is Avatar's choice. We promote our local restaurants such as Subway.*) Also the choice of a free express facial or a free express massage or a regular manicure. This is a value of up to \$100

As we value suggestions from all of our Guests, we hope that you will give us feedback on how we can enhance our Onyx Membership Program.

I will give Avatar 30-day advance notice when I would like to cancel my membership. When I cancel my membership, Avatar will use the balance of the \$1000 available to them already and will no longer automatically withdrawal \$1,000. I understand that the balance available at that time will not be refunded to me. The balance will remain on account available to me until the end of that calendar year. After which, for liability purposes, \$10 will be deducted from the remaining balance each month until the balance reaches \$0. During this liability period, I still have an option to use the remaining balance. The \$10 deductions will not be refunded or added back to the account. If I choose to renew my membership during the liability period, upon completing a new membership form, I must still have \$1,000 withdrawn. Any balance left from the liability period will be added to the \$1,000 on account and the liability period will end.
